

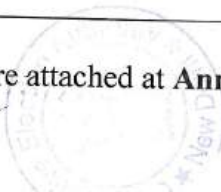

5. Detailed relevant important instructions on conduct of elections are attached at **Annexure-I**.

6. RO and Assistant Returning Officer is requested to ensure the election is conducted as per the MSCS Act, 2002 as amended by MSCS (Amendment) Act 2023 and Rules framed thereunder. In case any provision of Bye-Laws of the Society is inconsistent with the provision of Act and Rules made thereunder, then provisions of the Act/Rules shall prevail over such in-consistent provisions of the Bye-Laws and decision taken by CEA in this regard shall be final.

7. The Constituency shall be as per registered and approved Bye-Laws of the Society. Contestant would be from respective constituency. **Every voter member has a right to elect all the directors individually.**

8. RO and Assistant Returning Officer is advised to go through the documents meant for conduct of election- namely preparation of member list, preparation of voter list and information relating to seeking prior approval of Board of Directors and Office Bearers. These documents are available on the website <https://crcs.gov.in> under the heading "**Cooperative Election Authority**". Instructions contained in these documents must be followed in letter and spirit so as to ensure free and fair election.


